The NDE Germany aims to actively promote cooperation in this field. For this purpose the NDE Germany will be hosting two events at the COP22 in Morocco.

November 14, 2016. 14:30-16:00

The NDE Germany will be hosting a side event at the EU Pavilion (Room Brussels) on **Monday November 14, 2016 between 14:30 and 16:00**.

The side event will highlight first experiences and possibilities to contribute to the targets of the Paris Agreement through enhanced technology cooperation. It will analyse the **potential for collaboration between NDEs and involvement of the private sector**.

Access to advanced climate technologies from Annex I countries for mitigation and adaptation is crucial for developing countries to fulfil their ambitious climate targets under the Paris Agreement.

Matchmaking Dinner of the NDE Germany.

With this event the NDE Germany will provide a platform for **informal discussion and direct exchange for NDEs**, decision makers from industry, research and public bodies both from Germany and partner countries.

NDE Germany actively supports technology transfer

Opportunities for cooperation through the CTC-Network for German businesses

The Climate Technology Centre and Network (CTCN) offers technology providers the **opportunity to directly transfer their products or services to a new market**, through technology needs requests formulated by developing countries' NDEs.

German organisations, interested in offering their products and services in responding to such requests from the CTCN and developing countries, **will be actively supported by the NDE Germany** either in their effort of becoming a registered CTCN member or by getting access to project opportunities directly forwarded by the CTCN to the NDE Germany.

The CTCN is a central hub operated by UNEP and UNIDO to support developing countries with their technology needs through UN funded technology response plans. The CTCN is catalysing such technology requests from developing countries and asks its registered members to offer their relevant climate technologies and services.

The responses to requests are delivered in the form of technical assistance. The main types of technical support on climate technologies are technical assessments, technical support for policy and planning documents, trainings, tools and methodologies and implementation plans. These services can be particularly interesting to **German companies providing consulting, technical assistance or planning services**.

Only accredited and qualified technology and service providers can become CTC Network members and have access to technology transfer requests from developing countries. The benefits of a CTCN membership are:

- *Commercial opportunities:*
Pre-qualified access to competitive bidding for delivery of CTCN technical assistance services to developing countries



- **Networking:**
Access to the CTC network, decision makers within the UNFCCC technology mechanism
- **Visibility:**
Showcasing your organisations' services and capabilities through active involvement in the UN technology mechanism.

All legal entities can apply to become CTCN members. Candidates applying for a membership in the CTC Network must meet the following criteria, in order to be permitted:

- Demonstrated capabilities on technology cooperation (mitigation as well as adaptation) with developing countries or emerging economies
- Operational and organisational ability and strength
- Compliance with the CTCN code of conduct.

The CTCN also provides access via the NDE Germany to projects which will not be served by CTCN members. **The NDE plans to make these project opportunities available to German organisations registered on our website.**
